I wave all compensation for the use of my pictures, likenesses, or videos in any and all use. I agree that my Email and Social Media Accounts submitted may be shared to affiliates for advertising and or marketing purposes. I agree that I am required to compete in the division of sex that is recorded on my birth certificate, and if I am of minor age, I must have consent and be accompanied by my Legal Guardian at all times during the event. I agree to accept the results of Drug Testing, and if I request any further investigation it will be at my own expense.

COVID-19 WAIVER OF LIABILITY AND INDEMNIFICATION

I agree that I am personally responsible for my safety and actions while competing at the Florida State Natural Bodybuilding Championships, (FSNBC), and visiting Orlando Hilton Altamonte Springs, (OHAS). I agree to comply with all FSNBC/OHAS policies and rules, including but not limited to all SNBC/OHAS policies, guidelines, signage, and instructions. Because the FSNBC/OHAS is open for use by other individuals, I recognize that I am at higher risk of contracting COVID-19. With full awareness and appreciation of the risks involved, I, for myself and on behalf of my family, spouse, estate, heirs, executors, administrators, assigns, and personal representatives, hereby forever release, waive, discharge, and covenant not to sue FSNBC or OHAS, employees, successors, and assigns (collectively the “Released Parties”) from any and all liability, claims, demands, actions, and causes of action whatsoever, directly or indirectly arising out of or related to any loss, damage, or injury, including death, , that may be sustained by me related to COVID-19 whether caused by the negligence of the Released Parties, and third-party using the FSNBC/OHAS, or otherwise, while participating in any activity while in, on, or around the FSNBC/OHAS and/or while using any FSNBC/OMLM facilities, tools, equipment, or materials.

I agree to indemnify, defend, and hold harmless the Released Parties from and against any and all costs, expenses, damages, claims, lawsuits, judgements, losses, and/or liabilities (including attorney fees) arising either directly or indirectly from or related to any and all claims made by or against any of the Released Parties due the bodily injury, death, loss of use, monetary loss, or any other injury from or related to my use of the FSNBC/ OHAS facilities, tools, equipment, or materials, whether caused by the negligence of the Released Parties of otherwise specifically related to COVID-19.
